Jim McGraw – the agenda item is that the Supervisors have discussed for a period of a few months now their desire to form a planning commission to streamline items like subdivisions, the agenda item, itself is general, (discussion on forming a Planning Commission),

Jim McGraw – we are prepared with a draft ordinance to create a Board; some history is that there was a Planning Commission then it was abolished by a prior Board. This Board would like to re-establish the Board.

Jim McGraw – We prepared a draft ordinance to do this and due process requires us to do a first reading, advertising and posting then final approval if the Board is so inclined.

Jim McGraw- The Board may want to amend the agenda to say we are doing the first reading of the Planning Creation Ordinance.

Ed Shingle made the motion to amend the agenda to include the first read of the Planning Commission Creation Ordinance.

John Dewar – Why the change of heart, if you had this and you got read of it why are you going to bring in Planning Commission again?

Randy Polan – that was a different Administration at that time. It was abolished.

Ed Shingle – When it was abolished it has been weaponized, and we are hoping that this doesn't happen again.

Randy Polan second. Motion Carried 2/0.

Ed Shingle made the motion to do the first reading of the Ordinance creating the Township Planning Commission and approve advertising. Randy Polan second. Motion Carried 2/0.

Jim McGraw – The Township will need to pull the Ordinance number for this, I will now read the Proposed Ordinance.

Jim McGraw – we may need to check the date in Section #9 I think this should be 1998 we will check before advertising and adoption.

Ed Shingle – We will need to send to the county once adopted.

2. Water Operator

Ed Shingle – We need to look at the contract in executive session.

After coming back from executive session Ed Shingle stated that this needs tabled.

Ed Shingle made the motion to table the Water Operator item. Randy Polan second. Motion Carried 2/0.

3. Roberts Subdivision for review
