Thank you for writing to Donegal Township to request records pursuant to Pennsylvania's Right-to-Know Law ("RTKL"), 65 P.S. §§ 67.101 *et seq*.

On March 25, 2024 Donegal Township received your requested dated March 24,2024. You requested: "I am requesting the Lynch Law Group invoices to Donegal Township, Washington County for February, March, July August of 2023." Your request is granted in part and denied in part as follows:

Records responsive to Lynch Law Group invoices to Donegal Township Washington County for February, March, July of 2023 is *granted* and *attached*, *to this email*.


On September 4, 2023, you requested Lynch Law invoices for August 2023. Your request was sent via email to you on September 11,2023. Therefore, this portion is denied based on duplication of the same requested information from a previous RTK dated September 4, 2023.







Thank you for writing to Donegal Township to request records pursuant to Pennsylvania's Right-to-Know Law ("RTKL"), 65 P.S. §§ 67.101 *et seq*.
